ACCIDENT, INCIDENT, INJURY, TRAUMA & ILLNESS POLICY

AIM:

To establish clear lines of action to effectively manage an event involving a child becoming ill, injured ,or involved in an incident.

EXPLANATION:

It is important for the safety of children that procedures are followed through in the event that a child becomes injured, becomes unwell, or an incident occurs while attending the service. The safety, health an wellbeing of children is a paramount consideration for our service.

IMPLEMENTATION:

- Nominated Supervisor is to ensure that first aid kit is well stocked at all times.
- All Educators are to have current first aid certificates. (HLTAID004/012)
- First Aid supplies are to be kept out of reach of children.
- Portable First Aid Kit is to be taken on all excursions.
- Follow health and hygiene policy when dealing with first aid.
- Blood to be washed down and cleaned with bleach (blood spills bucket) immediately. All items used
 in process of cleaning and first aid should be disposed of immediately by being wrapped up and
 placed in outdoor bins.
- Body Fluids (including vomit) to be washed down and cleaned with detergent immediately. All items
 used in process of cleaning and first aid should be disposed of immediately by being wrapped up and
 placed in outdoor bins.
- Staff ensure playground is kept safe and equipment is placed in safe areas with adequate soft fall underneath.
- Staff will maintain high levels of supervision.
- A Responsible Person is required to complete the accident/incident/injury/trauma/illness forms in conjunction with the witness of the accident/incident/injury/trauma/illness. Then the Director/Nominated person will read and sign it and follow up on any concerning accident/incident/injury/trauma/illness in order to report serious incidents to the department within 24 hours.
- Families will be informed of any accident/incident/injury/trauma/illness involving their child. Any serious incident will be notified to the parent as soon as possible as paramount.
- Care will be taken when assessing the seriousness of an accident/incident/injury/trauma/illness and if there is need for emergency services to attend.
- In the event of an accident/incident/injury/trauma/illness we will review the cause and take appropriate action where appropriate.
- Confidentiality is important and will be maintained at all times
- High levels of supervision will be maintained and ratios will be met at all times. Supervision plans will be regularly reviewed.

MINOR ACCIDENT/INCIDENT/INJURY/ILLNESS

Educators will ensure:

- Child is given immediate first aid appropriate to accident/incident/injury/trauma/illness by staff with current First Aid Certificate.
- Details are recorded on accident/incident/injury/trauma/illness (see First Aid Policy) which must be signed when child is collected.
- Parents are notified on collection of child. Parents will be notified at the time of any head injury occurring.
- In the event of an accident, incident, injury or illness parents need to be notified within 24hrs of the event.
- Follow up with parents if any medical attention was sought in order to notify the department of a 'serious incident' within 24 hours

If requiring more First Aid or medical treatment:

- Staff to contact parents/guardian to alert them of accident/incident/injury/trauma/illness and ask them to collect child from pre-school and seek further medical attention.
- Child to be monitored by staff until parent/guardian takes responsibility.
- A notification must be sent to The Regulatory Authority through the NQAITS and notify the Area
 Director who will report to the Executive Director on behalf of the Approved Provider.
 accident/incident/injury/trauma/illness report completed, duplicated and signed by parent/guardian.
 A copy must be kept with child's developmental record.

MAJOR INJURY

- First aid to be given immediately by a staff member with approved first aid qualification.
- Staff to contact emergency services on 000.
- Staff to contact parents/guardians or if unavailable to contact other authorised persons and request they come immediately to the Centre.
- The person responsible for the child (staff or parent) to accompany child to hospital in ambulance.
- A notification must be sent to The Regulatory Authority through the NQAITS and notify the Area
 Director who will report to the Executive Director on behalf of the Approved Provider.
 accident/incident/injury/trauma/illness report completed, duplicated and signed by parent/guardian.
 A copy must be kept with child's developmental record.

Injury	Any physical damage to the body caused by violence or an incident.	
Medication	Medicine within the meaning of the <i>Therapeutic Goods Act 1989</i> of the Commonwealth. Medicine includes prescription, over-the-counter and complementary medicines. Notifiable incident	Any incidents that seriously compromise the safety, health or wellbeing of children. The notification needs to be provided to the regulatory authority and also to parents within 24 hours of a serious incident. Serious incident	For the purposes of the definition of serious incident in section 5(1) of the Law, each of the following is prescribed as a serious incident: (a) the death of a child— (i) while that child is being educated and cared for by an education and care service; or (ii) following an incident occurring while that child was being educated and cared for by an education and care service; (b) any incident involving serious injury or trauma to a child occurring while that child is being educated and cared for by an education and care service— (i) which a reasonable person would consider required urgent medical attention from a registered medical practitioner; or (ii) for which the child attended, or ought reasonably to have attended, a hospital; Example: A broken limb. (c) any incident involving serious illness of a child occurring while that child is being educated and cared for by an education and care service for which the child attended, or ought reasonably to have attended, a hospital; Example: Severe asthma attack, seizure or anaphylaxis reaction. (d) any emergency for which emergency services attended; (e) any circumstance where a child being educated and cared for by an education and care service— (i) appears to be missing or cannot be accounted for; or (ii) appears to have been taken or removed from the education and care service premises in a manner that contravenes these Regulations; or	National Regulations (Regulation 12)
